Richard Manhattan: Thank you. Good morning, Chair Lombardo, Members of the Board. My name is Richard Manhattan with Properion. It's a Nevada domiciled sole proprietorship based in unincorporated Clark County, Nevada. I'm here today to discuss items that are listed in contracts for approval. There are two contracts that are slated for approval that have been noticed of intent by the Nevada Department of Tourism. The first is 10TCA-S2275, Germany Representation Office, and the second is 10TCA-S2258, which is the United Kingdom representation office.

In a perfect world, I noticed that this is my first time here and there are a number of people here and so it seems time is of the essence. Thank you very much. But in a perfect world, if there is an appetite for it, it would be wonderful to pull these items out of the consent agenda for contract approval for additional discussion. I'll leave that to the board's discretion, but of course, I would generally like to discuss how my experience as a small business owner and bidding on these contracts and what I perceive and our team perceives as some practices that can be addressed perhaps by the purchasing department and by agencies at the state level to make it a little bit more feasible for small businesses to bid and compete on contracts of this nature. There is a noticeable variation in-between how agencies in Clark County bid on or allow firms to bid on contracts and how it's done at the state level. And I particularly want to say that the agency has indicated they'd like to award these firms to one German-based firm and then one UK-based firm. I will just focus on the German one for now, but if you look at the arrival statistics from both the LVCVA and the McCarran statistics, there hasn't been appreciable growth in arrival from those markets over the timeframe, over the past 10 years, and the agency has already had a 10-year long-standing relationship with one of these firms in Germany. And so I'll leave it at that and ask that if there's an opportunity to discuss this more during that timeframe, that I'll stick around in case you have time.
