The 2023 Legislature, through Assembly Bill 522, made appropriations from the General Fund and the Highway Fund to the Board of Examiners to meet salary deficiencies that may be created between the appropriated money of the State's respective departments, commissions, and agencies and the salary requirements for the personnel of those departments, commissions, and agencies.

Request A is from the Office of the Lieutenant Governor in the amount of \$50,486 for salary increases.

Request B is from the Office of the Chief Information Officer in the amount of \$45,898 for salary increases.

Governor: Since Colorado River Commission was brought up, for Lease #1, we're seeing an adjusted total here, correct? The previous version was over \$1 million.

Clerk of the Board: Yes, this item was corrected.

Governor: Do we have any other questions on agenda item number nine?

Governor: We have a motion for approval. All those in favor, signify by saying aye. The motion passes unanimously.

10. Approval of Proposed Contracts (For possible action)

Governor: We will move on to agenda item number 10, *Approval of Proposed Contracts*.

Clerk of the Board: There are 40 contracts under agenda item number 10 for approval by the Board today. Are there any questions on any of these items?

Governor: Yes, I have a question on contract number 11 with the Department of Veterans Services. Is Colonel Devine there in Carson City? Do you mind coming forward?

Mary Devine: Good morning, Governor.

Governor: Is anybody there from Health Dimensions Consulting (HDG)?

Mary Devine: They are not here right now.

Governor: My question is specific to them. On their plan on moving forward, since we're changing vendors, I just wanted to have some sort of confidence and know what their previous experience in this type of work is. I don't know if you're able to answer those questions, Colonel Devine.

Mary Devine: My team and I can answer the questions.

Governor: Please enlighten the Board on what exactly is going to change from the previous vendor to ensure that we increase upon the star rating and the management of the facility.

Mary Devine: We'll start with the management of the facility. Overall, we have many more operational controls put in place. The internal controls have increased substantially with oversight in hiring and budget activities. The accounting team and the healthcare services team will be providing weekly audits on specific expenditures, as well as monthly reviews of payroll and all accounts receivable and payable transactions will be reviewed on a quarterly basis and certain things on a daily basis. HDC will be providing a daily financial oversight report to the accounting section, as well as multiple other standard operating procedure changes and monthly budget review.

Governor: Are you familiar with their track record?

Mary Devine: Yes. They have been awarded many different awards over the course of the last two years. They received the 2022 Silver National Quality Award from the American Association for medical services and skilled nursing facilities. They are up for the gold award for 2023. They've also been recognized in 2022, 2023, 2024 as an outstanding employer by their local news reports. So, they do have a very solid track record for quality improvement in their facilities. I believe they are five-star facilities in most locations.

We've worked with them extensively over the course of the last month to put in place a kind of a wraparound services to take a look at everything from how we do admissions, how we will work with families, how we'll integrate the residents' counsel, how we will work with all of the different equities from supply chain deliveries, all the way through any quality of life issue and working with our residents' counsel. The CEO of HDG has met with our resident counsel president and is already working with him to implement a new employee training program.

Governor: All sounds good. So when does the contract go into place or functionality? Is it in August, late August, end of August?

Mary Devine: August 13 is when HDG would take over. Joe has the specifics. I'll let him address that.

Joe Theile: Joe Theili for the record. Upon approval of the Board, they will be in the facility tomorrow, as we will also be with the staff. We'll have an overlap with the present vendor through August 13.

Governor: That was my concern, whether the transition would be seamless or not because we can't afford the void of services during that time. Last question is, since we're having trouble hiring folks and across the board, not necessarily the state but private entities also, are there any issues with the staffing needed to honor the contract?

Mary Devine: HDG and the current vendor Avalon Care Center - VA Reno, LLC (Avalon) are working together to hire all of our critical positions. We have had turnover in director of nursing as well as the home administrator and infection control but we do currently have temporary backfills in each of those positions and HDG will be conducting interviews as soon as they hit the ground.

Governor: Great. Are there any other questions?

Attorney General: If I could just follow up quickly on the transition there. Just to be clear, we're contemplating a smooth transition between Avalon and HDG with Avalon and HDG agreeing to work together and ensure continuity of services pending this contract being approved. Is that right?

Mary Devine: Yes.

Attorney General: What type of assurances have you received relative to that particular cooperation?

Mary Devine: Currently, they're meeting on a daily basis for the transition with my team as with Avalon's team and HDG's team to ensure a continuity of operations. They're talking through everything from just routine resident care all the way through their HR practices, accounting practices, and I have at least one member, if not up to three or four members of the Department of Veterans Services team available in those meetings to make sure that the continuity is going well and we are actually receiving all the documents and archiving all the historical information that we need.

Attorney General: Have we had any hiccups to-date that you can share with us? Any concerns that have arisen about the transition that you can discuss?

Mary Devine: Nothing significant. Really, the biggest concern is making sure that all the critical positions are filled in a timely manner and that we have quality applicants so that we don't have any interruptions in resident care, making sure that the integration of our resident council is taken into consideration in everything that we do so that the residents have a reasonable expectation that their care will continue at the standard that they're used to.

Attorney General: Thank you. And I'll just say as an aside that I would highly recommend and suggest that you continue communications with your council relative to

this transition to ensure dotting the i's and crossing the t's. Then, we can help to ensure that this transition goes seamlessly as well.

Mary Devine: Thank you. Our council has been incredibly supportive. They have been with us every day and are here now. So, we definitely appreciate the support that we've received from your office.

Attorney General: That council sounds fantastic. Thank you so much.

Governor: Then, I guess it's similar but separate, what's the current status, Colonel, of the air conditioning system, the cooling system there?

Mary Devine: I spoke with the Department of Administration, State Public Works Division this morning. They are working with the original vendor to see if we can get those compressors on order so we can get out of using the temporary compressor that we are using right now that's costing us about \$25,000 a month.

We're also working on a permanent fix to replace all of our heating, ventilation, and air conditioning (HVAC) in the northern system, a CIP project for that. So, basically, our holdup for fixing it, the existing system has been product manufacturing. Those systems came out of Canada and the parts that we need are not available right now and we're working on that.

We're also doing a full review of the Boulder City home to make sure that there's redundancy there so we don't experience any problems with that. We're working with the architects for the new northern Las Vegas home to make sure that we have robust redundancy in all HVAC systems as we develop the new home.

Governor: Great. Thank you. Are there any other questions?

Secretary of State: No questions. Thank you.

Governor: Alright, if there are no further questions, I'll entertain a motion for approval of agenda item number 10.

Attorney General: I move approval of agenda item number 10.

Governor: We have a motion for approval. All those in favor, signify by saying aye. Mr. Aguilar?
