7. Request for a Recommendation of Approval to the Interim Finance Committee for an Allocation Amount from the Contingency Account (For possible action)

A. Department of Human Services – Division of Public and Behavioral Health

Pursuant to NRS 353.268, the department requests a recommendation to the Interim Finance Committee for an allocation of \$991,147 from the Interim Finance Committee Contingency Account to fund projected shortfalls in Personnel Services.

8. Request for Transfer from the State General Fund (For possible action)

Office of the State Treasurer – Unclaimed Property

Pursuant to NRS 120A.620, section 6, the office requests approval of a temporary transfer of \$50,000,000 from the State General Fund to the Abandoned Property Trust Account to allow the office to meet its obligations to pay approved property claims.

Governor: Agenda item number eight, *Request for Transfer from the State General Fund, for Possible Action.* Ms. Greenameyer.

Clerk of the Board: This request is from the Office of the Treasurer, Unclaimed Property. Pursuant to NRS 120A.620, section 6, the office requests the approval of a temporary transfer of \$50,000,000 to the State General Fund to the Abandoned Property Trust Account to allow the office to meet its obligations to pay approved property claims. Are there any questions on this item?

Governor: Yes, Ms. Hoover, can you come forward? Kirsten, are you there in Las Vegas?

Kirsten Van Ry: Kirsten Van Ry, Chief of Staff with the State Treasurer's Office. Yes, I'm here, Governor.

Governor: Could you just clarify why it's a temporary transfer and why it's needed?

Kirsten Van Ry: Yes, so, how this request came about is the previous Advantage 2 system used to allow our budget accounts to go into the negative. We have a statutory authority to pay approved claims within 30 days for the Unclaimed Property Program. Unfortunately, the new system does not yet allow us to do that. So, this request will allow us to fund out those approved unplanned property claims within the statutory timeframe and then, we will make up the dollars when unclaimed property reporting is due to the state which happens on October 31st each year.

Governor: Okay, and do you have a timeline when the fix will be put in place?

Clerk of the Board: So, Advantage 4 is currently working through the Budget Override issue.

We do have an override now. It currently takes three people to process a transaction on a budget account override. We are coming up with different ideas to solve that problem. It will probably take a couple of months to figure out which direction we are going to go.

Governor: Alright, thank you and we appreciate the information. Thanks, Lori. With that being said, are there any further questions from any Board Members?

Secretary of State: No questions.

Attorney General: Move for approval.

Emma Rodriguez: Good morning, my name is Emma Rodriguez and I serve as the Communications and Legislative Affairs Administrator for the Southern Nevada Health District. Jeanne Freeman: Good morning. Jeanne Freeman, Director for Carson City Health and Human Services. I want to thank the 82nd Session of the Nevada Legislature for the initial public health funding provided through Senate Bill 118, as well as Governor Lombardo for the public health improvement funds included in this current budget. These funds are making measurable impact on the health of Carson City residents, including our youth, seniors and everyone in-between.

These funds have been, and will continue to be, used to support overall health of our community.
