I would note contract #6 with the Division of Human Resource Management and the Simmons Group as well as contract #13 with Medicaid and University of Nevada, Reno have been withdrawn by the agencies. **Governor**: Yes. Now let's go to contracts #19 through 24. There is a significant amount of money associated with each one of these contracts. A total of five at \$12 million each – can you just walk me through why they're all of similar amounts and why it's purposeful for that?

**Jennifer Krupp:** Thank you for the question. Jennifer Krupp, for the record. These contracts are built off of the expected per member, per month, that we would anticipate paying for Medicaid recipients through the course of the five-year contract that begins January 1, 2026. These contracts do represent the amount of capitation payments we would expect to pay for the medical services for these Medicaid beneficiaries.

Governor: So, is that a standard procedure that we've done in previous years?

Jennifer Krupp: It is.

Governor: So, it's just an encumbrance, it's not a payment?

**Jennifer Krupp:** It is an encumbrance, yes. It could change depending on how our caseload changes throughout the term of the contract. In whether enrollment goes up or down.

**Theresa Carsten:** Teresa Carson for the record. Additionally, Governor, members have choice as to plans. They have a choice into a plan, and those that don't make a choice, are assigned into a plan. So, with that movement, it is unknown which plan individuals will end up on. A not-to-exceed amount, that is the same across all of the plans, allows for that movement without the need for continual amendments to each of the contracts.
