A. Governor's Finance Office – Budget Division

Pursuant to NRS Chapter 353, the division presents a reconciled fund balance report for the Tort Claim Fund, Statutory Contingency Account, Stale Claims Account, Emergency Account, Disaster Relief Account, and the IFC Contingency Fund as of August 14, 2025 for fiscal year 2025. Additionally, a reconciliation of the Extradition Coordinator budget account has been prepared at the request of the Board.

B. Statewide Quarterly Overtime Report – Fiscal Year 2025, 4th Quarter

Pursuant to NRS 284.180, the Department of Administration, Division of Human Resource Management must prepare and submit quarterly to the Budget Division of the Office of Finance a report regarding all overtime worked by employees of the Executive Department during the quarter. The Budget Division shall transmit quarterly to the Board of Examiners the report and the analysis of the Budget

Division regarding the report. This report covers the period of April 1, 2025 through June 30, 2025.

C. State Department of Conservation and Natural Resources – Division of State Lands – Fiscal Year 2025, 4th Quarter

Pursuant to NRS 321.5954, subsection 4, the State Land Registrar is required to provide the Board of Examiners quarterly reports regarding lands or interests in lands transferred, sold, exchanged, or leased under the Tahoe Basin Act program. This report covers the period of April 1, 2025 through June 30, 2025.

Governor: Agenda item number 13, *Information Item Reports*. We'll take them separately.

Clerk of the Board: The first report is from the Governor's Finance Office, Budget Division. Pursuant to NRS Chapter 353, the division presents a reconciled fund balance report of the following accounts. The approximate balances are as follows:

Tort Claim Fund is \$385,000; Statutory Contingency Account, \$8.5M; Stale Claims Account, \$4M; Emergency Account, \$450,000; Disaster Relief Account, \$14.5M; IFC Contingency Unrestricted General Fund, \$36.4M; IFC Contingency Unrestricted Highway Fund, \$1.6M; IFC Contingency Restricted General Fund, \$105.6M; IFC Contingency Restricted Highway Fund, \$18.8M; and Extradition Coordinator, Budget Account 1002 is \$517,000. This item is informational. Are there any questions on any of these?

Secretary of State: I do have a question. Nevada Department of Corrections, wrongful death future payment, \$4.6 million – what have we paid in the last year on these claims? I don't know if this is an appropriate question for this item.

Governor: Do you have that answer available now, or do we need a written response?

Clerk of the Board: To provide detailed information, I would have to provide that in writing. We can get that to you.

Secretary of State: Is this something we could bring up at the Board of State Prison Commissioners meeting?

Attorney General: I think so.

Secretary of State: Okay.

Attorney General: Craig, I don't know if by chance you have any recollection of the last year amount?

Craig Newby: Craig Newby, Office of the Attorney General for the record. I would not want to try to do the math from my memory for the purpose of an exact number but certainly there has been an increase.

I'm aware of what the \$4.6 million number is in reference to. That will be for this body's consideration next month.

I'd be happy to pull together the numbers of the last year working with the Governor's Finance Office to make sure we have the numbers matched up to the matters and provide that to you, Mr. Secretary.

Secretary of State: Thank you.

Craig Newby: It's probably a policy discussion for the Board of State Prison Commissioners.

Secretary of State: Absolutely, thank you.

Governor: Alright, let's move on to report 13.B.

Clerk of the Board: The second report is the Statewide Quarterly Overtime Report, Fiscal Year 2025, 4th Quarter. Pursuant to NRS 284.180, the Department of Administration, Division of Human Resource Management must prepare and submit quarterly to the Budget Division of the Office of Finance a report regarding all overtime worked by employees of the Executive Department during the quarter. This report covers the period of April 1, 2025 through June 30, 2025. Are there any questions on any of these?

Governor: Yes, do we have anybody from Department of Corrections there?

Director Dzurenda: This is James Dzurenda for the record, director for the Department of Corrections.

Governor: Yes, in reference to your overtime and the continued issue that we keep trying to address, the programs that we've developed over the last 12 months, are they working, not working? Do we need to make adjustments? What needs to be done and possible legislation in the next cycle? Just give us a general update on that. Let's not get into minutiae or the reasons why. I would like you to respond on identified possible solutions or identified issues that we have to continue to address.

Director Dzurenda: Yes, sir. So, this is James Dzurenda for the record. So, the Department of Corrections, the way we are looking at reducing the overtime is, as we reduce functions inside the facility without jeopardizing any constitutional rights, which is reducing the out-of-cell time, reducing visits, which actually we utilize the officers that are in those positions to fill overtime posts.

We are in positions of procuring technology that can actually reduce drugs in the facilities. We are also teaming up with Health and Human Services to start combating substance abuse to try to start at the beginning to prevent the need for those incarcerated for trying to utilize the gangs to procure their drugs.

Governor: Director, I think we're getting a little muddy here on the response. I just want to know that we're being proactive and we're identifying programs that are working and not working and we're going to continue to evaluate. Is that an accurate assessment?

Director Dzurenda: Sure. We're doing everything we can to look at our overtime costs and try to reduce it by also making sure that we do everything we can safely and securely for the population and for the staff. Right now, the staff are doing everything they possibly can to reduce the overtime so it doesn't have a larger effect in the facilities and the budget.

The last thing is, we have legislatively approved additional positions that were given to the department and budgeted for that come on board starting October 1st. So, once those positions come on board, we'll start the recruiting and backfilling of those positions if they were pulled from the facility. Those positions that were given to us will actually help in reducing the overtime costs that we were previously not budgeted for as well.

Governor: Those positions don't have an immediate effect, correct, because of the training that goes along with it?

Director Dzurenda: That is correct. We would have to post for staff to put in for those positions first that are currently working. Once they accept those positions, they would have to be trained in those positions. At the same time, those that were pulled to fill those positions, their current positions would have to be recruited for for new staff to be trained at the Academy to fill in. So, for those positions, you probably won't see a start in reduction of overtime for at least six to eight months.

Governor: Alright, thank you. Are there any other questions before we move on? Hearing none, we will move on to 13.C.

Clerk of the Board: The last report is for the State Department of Conservation and Natural Resources, Division of State Lands, Fiscal Year 2025, 4th Quarter.
