In FY 2016, the rate is scheduled to revert to the FY 2009 rate of 0.63% on all taxable wages with no exempted amounts.





Statewide Taxable Sales & Use by Industry




Average Daily Gaming Percentage Fee Collections
















Nevada Single Family Home Permits Issued Each Month


