SB424 (2021)

- The Public Health Resource Office was created through SB424 of the 2021 legislative session.
- The bill created two positions:
 - The Public Health Resource Officer;
 - Health Program Specialist I in the Nevada Office of Minority Health and Equity (NOMHE).
- The Public Health Resource Office operates under NRS 233.085 in the Office of the Governor.
- Governor Sisolak appointed the Public Health Resource Officer position in April 2021.

Responsibilities

- The Public Health Resource Officer is tasked with the following:
 - Examining Nevada's public health infrastructure;
 - Identify unmet needs for public health services;
 - Identify opportunities to obtain federal or private funding to support public health services;
 - Identify ways to improve coordination between public health providers and to maximize efficiency in the delivery of public health services;
 - Make recommendations to the Governor, Legislature, Director of the Department of Health and Human Services and the Administrator of the Division of Public and Behavioral Health on those findings.

NOMHE Collaboration

- As previously mentioned, SB424 also created a position in the Nevada Office of Minority Health and Equity.
- This position is required to do the following:
 - Research and make recommendations to the Public Health Resource Office concerning strategies to address health disparity outcomes in:
 - 1. Communities of Black persons, Indigenous persons and persons of color resulting from system racism and structures of racial discrimination; and
 - 2. Rural communities and other underserved communities.
- This position was recently filled by Karina Fox.
- The Public Health Resource Office (PHRO) also meets with NOMHE, Office for New Americans and the Nevada Indian Commission to discuss the opportunities mentioned above.

 - Nevada Department of Wildlife


